### ❖ International Human Rights Day concert on Dec 10, 2013

Emancipation Park. Theme: *Divine Design: Celebrating God the Giver of Perfect Laws and Perfect Rights.* **Speaker: Brian Camenker**, founder of pro-family activist organisation Mass Resistance in Massachusetts, USA. He warned Jamaica of the impending tsunami of upheavals to our social, political and business society should the buggery law be repealed, based on the severe repercussions experienced in Massachusetts which has legalised gay marriage. ## What's happening: Jamaica

### ❖ Javed Jaghai v Attorney General of Jamaica

Mr Jaghai filed a constitutional challenge to the Buggery Law and seeks constitutional redress from the alleged abrogation that the Buggery Law impinges on his right of privacy and equality . The trial date has been set for November 2014 .

Caribbean DAWN, a women's pro- gender equality NGO supporting repeal of the buggery law, was granted interested party status. A similar application by Jamaicans for Justice was denied.

## ❖ Maurice Tomlinson v TVJ,CVM, PBCJ

Nov 15,2013

The Constitutional Court handed down its ruling on the application by gay rights activist Maurice Tomlinson, challenging the refusal by the television stations to air an advertisement promoting tolerance for homosexuals.

Mr Tomlinson argued that the non-broadcast of his ads was a breach of his right to freedom of expression and right to receive and disseminate ideas under sections 13 (c) & (d) of the Charter of Fundamental Rights and Freedoms of the Jamaican Constitution. The Court ruled that these sections did not give anyone the right to use another private person's property to disseminate any messages. Also editorial press freedom and control gave the stations the right to determine what, when and how they broadcast content relating to issues of public concern, "bearing in mind the cultural, social, political and economic context in which they operate".

## Office of the Children's Advocate Child Justice Guidelines, Nov 20,2013

Although an otherwise laudable document, the Guidelines provide for sexual orientation as a prohibited ground of discrimination (Part 1 Principle 4 and Part 2 A 20). The JCHS agrees that all persons, including children, must be treated equally before the law but introducing this concept has the effect of superseding Parliament which had **rejected** the inclusion of sexual orientation in the Charter of Rights during its debates in 2006 (proposed by J-Flag).

The more this phrase is stealthily inserted into Government and private sector documents such as staff manuals, IT MAY ACHIEVE THE NORMALISATION OF HOMOSEXUAL BEHAVIOUR WITHOUT AMENDING or REPEALING THE BUGGERY LAW!

## Statement of intention by Minister of Justice, Senator Mark Golding

At a public forum on human rights hosted by Jamaicans for Justice on November 12,2013, the Minister indicated his intention to review the Sexual Offences Act in 2014, decriminalise teenage promiscuity, and adopt a Discrimination Act including sexual orientation, so as to introduce "new principles of morality" to Jamaica.

## What's happening: the World

### The Commonwealth of Australia v The Australian Capital Territory (ACT)

The Australian High Court held on Thursday, 12 December 2013 that the *Marriage Equality (Same Sex) Act 2013*, enacted by the Legislative Assembly for ACT, cannot operate concurrently with the federal *Marriage Act 1961* which does not allow or recognise marriages between same sex couples. Only the Federal Parliament has constitutional power to legislate on same sex marriage. Pressure is now being brought on the Government to allow a conscience vote on the matter and for same-sex "marriage" bills to be brought forward in both Houses of Parliament.

## ❖ Suresh Kumar Koushal and another v NAZ Foundation

December 11, 2013, the Indian Supreme Court upheld as constitutionally valid, s.377, Indian Penal Code which criminalises 'carnal acts against the order of nature'. This reverses a 2009 ruling which decriminalised homosexuality. The Court said it was up to Parliament to decide whether or not to retain the law. The Government has since indicated its intention to explore how to restore the 2009 ruling.

## ❖ Although their Government is for gay marriage, 65% of Croatians

voted by referendum on December 1, 2013, to constitutionally define marriage as a union between 1 man and 1 woman.
